

### "Spotlight on Excellence" Awards Banquet



#### "Why We Choose Healthcare and How Healthcare Continues to Choose Us"

Just like his football career, Mr. Smith had to fight, claw, and scratch his way from the projects in Texarkana, Arkansas to the become a 2X Superbowl Champion and soon to be Hall Of Famer. He is a highly sought after spokesman for several fortune 500 companies like the Denver Broncos,

Fed Ex, Visa, Cadillac, Nike, and Intuit to name a few. He earned 3 college degrees in business. Growing up poor was a very humbling experience for Mr. Smith. As he climbed out of the ghetto to get full scholarships to college, he documented the process along the way. Transitioning out of college to the NFL was no easy feat. But the same dreaming philosophies he used before would help propel him once again.

He studied and learn to master these 8 Simple, yet Powerful Philosophies that made him a multiple 7 figure earner. Along the path to success were some trials, some pain, and plenty of disappointments. All the while he crafted a playbook for a lifetime of success.

## Tuesday, September 20th

Delivering Quality and Maximizing Your Pay for Performance (P4P)

FIRTERES

This informative program will update attendees on the Pay For Performance (P4P) Application process step by step.

Moderator: JANET SNIPES, Administrator of Holly Heights Nursing Care Center and the Immediate Past Chair of CHCA will discuss changes and walk participants through the application process. The speaker has extensive knowledge and experience in P4P both as members of the P4P subcommittee and practical experience in submission and review.

Total Industry Update

Changes are happening to payment, public reporting and regulations that are impacting how LTC provides care: What are the comment themes and how can I negotiation these changes to end out on top?

National and state payment policies are shifting rapidly, linking Medicare, Medicaid and Commercial insurance payments with quality, which will effect both Census and payment rates. This session will review several of the recent national policies linking payment with quality that will impact SNFs and ALs such as the 2% withhold linked to rehospitalization rates and the 90 day bundle payment following hip and knee surgery.

In addition CMS is significantly updating their regulatory requirements which focuses on avoiding hospitalizations and improving transitions of care. The Five Star system also is changing, adding new measures and being used by CMS in new payment models. Five Star is more under one control than people realize. This session will review the common themes across all these changes and highlight some strategies on how to negotiate these changes so SNFs and ALs end out on top.

6 Are you Ruled Out?

There are new state and federal regulations, initiatives, payment models, Coding Clinic® interpretations, Official ICD-10-CM Coding Guidelines that have come or are coming by October 1st 2016. There is no department that has had more changes than the HIM department. What are the new rules and where are they located? How do we sort through which rule applies when? What are the implications for: documentation requirements, record completion, ICD-10 coding of claims and MDS; data collection and reporting?

Are the 1,943 new ICD-10-CM codes; 422 revised codes; and 305 deleted codes relevant to nursing communities? How about specificity in coding – what are we doing right and where do we need to improve? Will we need to revise codes based on all these changes? Are we querying enough? And then there are audits and surveys. What do we need to do to prepare for the new CMS focuses for the annual Colorado State surveys; MDS-Focused Survey; HIPAA Security Audits by the Office of Civil Rights; and all of the payment review auditors: ADR, CERT, MAC, RAC, MCFU, MIC, PERM, and ZPIC?

### ACOs and Other Alternative Payment Models: Structure of Models and Opportunities for Post-Acute Providers

Within the new health care environment, Accountable Care Organizations (ACOs) and other Alternate Payment Models (APMs) have a vested interest to coordinate care across the entire continuum. One area that often influences long term outcomes, is the care delivered within post-acute care (PAC) settings. Because of their high touch involvement with patients, both traditional and non-traditional PAC providers can help patients recover from acute procedures, prevent hospital readmissions, and provide effective care for ongoing chronic conditions. This presentation will provide an overview of ACOs and other APMs, explain the key drivers behind each model and highlight opportunities for the PAC Business Owner and Operator to strategically position themselves within any given market.

MICHELLE L. TEMPLIN is Vice President of Strategic Business Development for Managed Health Care Associates, Inc. (MHA), a leading health care services and technology company focused on the alternate site marketplace. Since 2013, Ms. Templin has led the strategy and management of the MHA ACO Network, which represents the nation's largest network of post-acute care (PAC) providers, including: long term care (LTC), home infusion and specialty pharmacies, DME and respiratory providers, and skilled nursing, assisted living and rehabilitation facilities. Working with ACOs, Medicare Advantage Plans and other payers, the MHA ACO Network assists in defining local Payer/PAC engagement strategies, provides critical resources for acute and post-acute provider connectivity, and analyzes the value of appropriate PAC utilization across the care continuum.

As a business thought leader on post-acute care, Ms. Templin currently co-chairs the WEDI Payment Model workgroup, which works to better understand and enhance HIT within emerging payment models. She is also a member of the National Association of ACOs (NAACOS), the Post-Acute Center for Research (PACCR), and is an active contributor and work group member to The Accountable Care Learning Collaborative sponsored by Leavitt Partners.

# Risky Business: The Importance of Complying with HIPAA and Conducting HIPAA Risk Assessments

Synopsis: In the past 13 years, more than 130,000 HIPAA complaints have been filed with the U.S. Department of Health and Human Services' Office for Civil Rights (the "OCR"), leading to settlements between the OCR and covered entities of more than \$33 million. A common violation of HIPAA is the failure of covered entities to conduct a thorough analysis of the risks to the confidentiality of electronic protected health information ("ePHI"). Covered entities are legally required under HIPAA to conduct a security risk assessment periodically to review the administrative, physical and technical safeguards the covered entities have in place to protect the security of their ePHI. By conducting these risk assessments, covered entities can uncover potential weaknesses in their security policies, processes, and systems, and address such vulnerabilities to bolster HIPAA compliance and protect against health data breaches and other adverse security events. This session will inform attendees of the current HIPAA enforcement landscape and focus points of the OCR, as well as educate attendees regarding the requirements of a HIPAA risk assessment and how to go

about performing one for their organizations.

She has represented numerous healthcare providers and pharmaceutical and medical device companies in complex regulatory and transactional matters. In 2015, the Colorado Advance Directives Consortium revised the MOST form extensively and developed a state-of-the-art, evidence-based protocol for conducting rich, illuminating, and person-centered conversations with patients, residents. and clients. In addition, Medicare introduced payment for advance care planning conversations and the 2016 Colorado legislature adopted important revisions to the Colorado Proxy Decision Maker statute. This interactive and informative session will present these updates and introduce a powerful new approach to advance care planning. All facility and residence staff will benefit from this workshop.

#### Infection Control

This presentation on Antibiotic Stewardship in LTC will cover the evolution of multi-drug resistant micro-organisms (M-DROs); the significance of appropriate use of laboratory testing; over utilization of antibiotics in the post-acute care setting; the rationale for optimization of antibiotic usage; and the 7 Core Elements of an Antibiotic Stewardship Program for nursing homes.

**DOLLY GREENE** is a registered nurse certified in infection prevention and control. She is the Director of Clinical Services and Education for Diagnostic Laboratories and Radiology and Mobilex USA. She has worked in the field of infection control for over 25 years and has been involved in long term care for over 30 years.

Dolly is a member of APIC, the Association of Professionals in Infection Control, and was part of the core faculty and one of the creators of an intense training program for Infection Preventionists in LTCFs in California. Dolly has spoken on Infection Prevention and Control at conferences and con-

ventions throughout the states and recently to infectious disease physicians at an international conference. Dolly received the SHEA (Society for Healthcare Epidemiology of America) Advanced Practice IP Award, and coauthored the APIC Infection Preventionist's Guide to LTC which was released in 2013.

## Legal UpdateLong Term Care-2015-16

This program is a survey reviewing significant National and Colorado legal developments affecting the long term care profession, including court cases and regulatory initiatives that have occurred throughout the course of the past year with a focus on matters that directly affect skilled nursing and assisted living facilities. National developments will cover congressional legislation, federal court decisions and CMS administrative regulations and policies as monitored by the American Health Care Association's Legal Committee. The Program will close with a review of the year's enforcement developments and survey trends for SNFs and ALRs as monitored by Husch Blackwell on behalf of the Colorado Health Care Association.
