The guidance touches a broad range of topics: involuntary discharges, trauma-informed care, arbitration agreements, abuse allegations, mental health, determining psychosocial harm, and the inappropriate use of antipsychotics.

Courtney Bishnoi serves as Vice President of Quality and Programs at the AHCA and NCAL. Courtney oversees the AHCA/NCAL Quality Award program. She has led the Quality Initiative. Courtney oversees AHCA's policy efforts about nursing home staffing ratios, working with states and policy makers to understand the impact of staffing levels. She guided the re-endorsement by the National Quality Forum of AHCA's customer satisfaction measures, CoreQ, as well as their inclusion in several states payment and regulatory programs. Since the start of the pandemic, she has led the associations efforts related to COVID-19 testing and vaccine distribution in long term care facilities, serving as primary liaison to CMS, HHS and CDC teams as well as academic partners to develop testing and vaccine quidance and resource for LTC providers.

For the last seven years, Christian Living Communities has been her home base, where she works with Pat McBride to learn, promote, and oversee risk management and a Just Culture.

# Legal, Legislative and Regulatory Update for 2022

Speakers: Fred Miles, Greenberg Traurig, Arlene Miles, Consultant Jenny Albertson, CHCA

The past year has brought significant legal, legislative and regulatory developments to the long- term care industry. We have seen important case decisions at the federal level involving challenges to government regulations and policies adopted in response to the COVID-19 epidemic, as well as related cases in the arena of civil liability. At the state level, the General Assembly passed legislation to enhance reimbursement for COVID-19 countermeasures, regulate supplemental staffing agencies and provide nursing home property tax relief. Regulatorily, CMS is moving on initiatives to enforce the Medicare/Medicaid Requirements of Participation, dovetailing with the Biden Administration's directives for our industry.

This program will be a general survey of these developments. The legal update portion of the program will be presented by Fred Miles, Of Counsel at Greenberg Traurig LLP, CHCA's General Counsel. The legislative update will be presented by Arlene Miles, CHCA's Chief Lobbyist. Regulatory matters and trends will be presented by Jenny Albertson, NHA, CHCA's Director of Quality and Regulatory Affairs. These presentations will be interactive with time allotted for questions and further dialogue with the audience.

Arlene Miles' long-term care career began with accounting and Medicare/ Medicaid reimbursement in a LTC Community in 1972. She continued her career by becoming an NHA. Arlene became the Executive Director of CHCA in 1983, and remained in that position for 33 years. She then transitioned to become the Executive Consultant for Government Affairs for CHCA.

Fred Miles, J.D., is a counselor for Greenberg Traurig, LLP. He is a nationally recognized expert in health law with an emphasis in representing providers in the post-acute services health care sector. He maintains an active regulatory trial practice, focusing on Medicare/Medicaid program issues including fraud and abuse, licensing, certification and reimbursement.

Jenny has spent the past seventeen years as a NHA. She has led 6 Colorado long-term, subacute, and dementia care facilities, and served on the Nursing Home Innovations Grants Board since 2016. In her new role At CHCA, she advocates for the nursing homes and assisted living facilities in the State, providing education, networking, and resources to the membership.

# Utilizing Therapy for Clients with Lower Skills to Achieve Better Quality Measures

Speaker: Neely Sullivan, Select Rehabilitation

Quality Measures (QMs) are used to measure health care processes, organizational structures, and outcomes that relate to aspects of high-quality care of patients. Therapists can use QMs to guide clinical decision making and evaluate and report treatment effectiveness for clients with lower skills to key stakeholders, including payers and clients. This session will review the reportable Skilled Nursing Quality Measures. Suggestions on how physical therapists can participate in QM initiatives and integrate a quality-of-care approach clinical practice will be made. This session will also offer tools and treatment strategies for working with patients with lower level skills. Using examples, clinicians will learn how to approach treatment sessions with this client population.

Neely Sullivan has worked with diverse client populations ranging from pediatrics to geriatrics in a variety of clinical settings. These experiences, as well as extensive education in health and wellness topics, have allowed her to develop and implement health and wellness programs for clients and employees. She has served in multiple regional and corporate management roles where she has developed health and wellness program policies. She works closely with multidisciplinary teams to ensure that all individuals have the opportunity to attain their highest level of function and quality of life.
